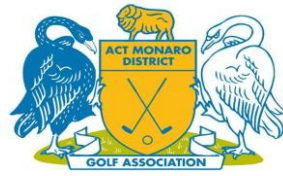

- the Player can demonstrate they are committed to their own personal development as a golfer, and
- that their coach/teaching professional can attest that they consider the Player to be of a level of suitability that they believe the Player is demonstrating a level of golfing proficiency that suggests the Player could develop into an elite level golfer.

The Player must be able to furnish a player logbook or other evidence that confirms their continual improvement/development as recorded by their coach/teaching professional, and this evidence is included as an attachment to this application. **YES / NO**

Both the Player and their Parent/Guardian agree to abide by the CSGA/ACT-M Junior Development Squad Code of Conduct (see attachment).

**CODE OF CONDUCT**

It would be impossible to define exactly the standard of conduct expected from a Player in all circumstances or to list all acts that would amount to a breach of the Code and lead to disciplinary sanction. In most cases common sense should tell the Player the standard of behaviour that is required.

Any Player who has any doubts as to the conduct which is expected of them should consult a CSGA/ACT-M official for guidance.

**GUIDELINES**

In most circumstances, the following acts or omissions by a Player will be considered to be breaches of the Code and may result in the immediate removal of the Player from the Junior Development Squad.

1. **Best Efforts** – Failure to give their best efforts in competition.
2. **Etiquette** – Failure to comply with normally accepted standards of courtesy and golf etiquette.
3. **Misbehaviour** – Misbehaviour of a personal nature that is generally unacceptable by normal social standards and which the CSGA and ACT-M in their sole discretion considers to be harmful to the reputation of either the CSGA, ACT-M or a venue club/facility, or an Event, or another Participant.
4. **Injurious Conduct** – Conduct likely to injure or discredit the reputation of the CSGA, ACT-M, or a venue club/facility, or an Event, or another Participant.
5. **Failure to Report a Breach of the Code** – Failure by a Participant to:
  - (i) Report a breach of the Code by another Participant when the breach is known to that Participant or in circumstances where they should reasonably have realised that a breach of the Code may have occurred; or
  - (ii) Fully cooperate in any enquiry or proceedings relating to a breach or suspected breach of the Code.
6. **Rules of Golf** – Failure to comply with the Rules of Golf, Local Rules, or Conditions of Competition.
